# **Filing Period**

#### Elections Filing Period Begins 3/1/21

File candidacy forms starting at 9:00am on 3/1/21.

#### Elections Filing Period Ends 3/12/21

No filing submissions shall be accepted past 5:00pm on 3/12/21. All applicable filing fees must be submitted to the LEAD Center Business and Finance Window by the close of the window on Friday, March 12. Candidates, party signatories, and primary proponents are responsible for ensuring that fees are submitted before the window closes. NOTE: The Business and Finance Window operates on its own hours, which are listed on the LEAD Center website. The Elections Council cannot accept filing fees unless they are submitted with the corresponding documentation to the Business and Finance Window within the window's own operating hours.

# **Campaign Period**

#### Mandatory Elections Meeting 3/16/21 - Time TBA

**MANDATORY** — All candidates, party signatories, and proposition proponents must be in attendance for the *entirety* of the meeting, which will cover election regulations and consequences for election violations.

#### Campaign Finance Period 1 Deadline 3/18/21

**MANDATORY** — All candidates, parties, and proposition proponents must report all campaign expenditures made, reserves received, and campaign contributions received between the end of the previous election cycle and 3/16/21 (inclusive). All reports must be submitted before 7:00pm on 3/18/21.

## **Election**

### Election Begins 4/5/21

Voters may cast their ballots (online via CalLink) starting 12:01am on 4/5/21. Physical polling stations will also be placed around campus and will be open from 9:00am to 4:00pm every day of the election period.

#### Election Ends 4/7/21

No voting shall take place past 11:59pm on 4/7/21.

#### Campaign Finance Period 2 Deadlines 3/17/21 - 4/7/21

**MANDATORY** – During this period, all campaign expenditures made, reverses received, and campaign contributions received *must* be reported within forty-eight (48) hours of receipt.

### Campaign Finance Period 3 Deadline 4/9/21

**MANDATORY** — All candidates, parties, and proposition proponents must report all campaign expenditures made, reserves received, and campaign contributions received after 4/7/21. All reports must be submitted no later than 11:59pm on 4/9/21.

### Tabulations Ceremony 4/9/21

The results of the election shall be announced. Time and location TBA.
