**OFFICIAL NOTIFICATION**

**Notice of Student Group Accountability Framework (SGAF) Interim Status Change**

Dear Vladyslav,

In your capacity as the primary student representative for **College Council (CC)**, I am contacting you on behalf of the Office of Student Conduct (OSC). The Office of Student Conduct has received information related to alleged conduct involving **College Council** throughout the timeframe of **April 7, 2025 and April 10, 2025**, that has raised concerns about the student organization's continued unrestricted presence on the Emory University campus.

Specifically, the allegation statement associated with the reported incident which, if true, would constitute a violation of the [Student Group Accountability Framework \(SGAF\)](#) and/or the [Emory University Undergraduate Code of Conduct](#) is as follows:

*According to information provided to the Office of Student Conduct, it is alleged that on or about April 7 and April 10, 2025, the Student Government Association (SGA) and the College Council (CC) engaged in misconduct potentially constituting discriminatory harassment, in violation of [Emory University's Policy 1.3 – Equal Opportunity and Discriminatory Harassment Policy](#). Specifically, it is alleged that members of both organizations publicly levied unsubstantiated allegations rooted in discriminatory assumptions, bias, and stereotypes, adversely impacting students' reputations, emotional wellbeing, and equitable access to leadership positions. These actions allegedly included making and permitting unfounded claims based on race, ethnicity, national origin, religion, and political views, creating an environment perceived as hostile and exclusionary to impacted students.*

Due to the seriousness of these allegation(s), and in accordance with the Emory University Undergraduate Code of Conduct, the OSC has deemed it necessary and appropriate to place **College Council** on immediate **Interim Measures** pending the outcome of a conduct investigation. As stated in our [Undergraduate Code of Conduct](#):

*Following OSC's receipt of a report, the University reserves the right to take prompt, interim, necessary, and appropriate action to protect the safety and well-being of the campus community. The AVP/DOS is charged with the welfare of all students. Accordingly, in appropriate situations, the AVP/DOS or their designee has full discretion and authority to deal with student conduct according to the exigencies of the situation and for its duration.*

### ***Interim Measure #1 - Requiring a Pause on all Activities and Meetings***

This pause **will take effect immediately and remain in place until the Office of Student Conduct completes its investigation and/or the conduct case is resolved**. During this pause, the student group must cease all group-related activities, including but not limited to meetings, sponsored or co-sponsored events, official gatherings, functions, advocacy initiatives, governance activities, programs, elections, and any other official student group business or proceedings.

The group is strictly prohibited from organizing, hosting, or participating in any events or activities, both on and off campus, that are connected to the group's identity, mission, or operations. This directive includes any events or gatherings in university-provided spaces or facilities typically reserved or regularly utilized by the group.

### ***Interim Measure #2 - Completing all University Directives***

All College Council members will be required to complete robust training in university policies, leadership, meeting management and other topics as outlined by Dean Odejimi. Dean Odejimi, or her designee, will determine if these parameters are met.

***Failure to comply with these directives will be considered a violation of the Undergraduate Code of Conduct and may result in disciplinary action.***

### **Organization President Responsibilities**

As President, you are responsible for ensuring that this notification and all related updates and information from the Office of Student Conduct are promptly and accurately communicated to all members. This includes the no-contact directive and the expectations outlined above. Failure to ensure that members are informed could result in additional charges or sanctions against the organization.

### **Request(s) for Review**

If the **College Council** has any pre-scheduled up-coming activities or events during the period in which the organization is on pause, the president must submit a written request for review to our office via email at [conduct@emory.edu](mailto:conduct@emory.edu). The request should include sufficient details about the planned event or activity to allow our office to assess whether it aligns with the conditions of the interim measures. This should include information such as the purpose of the event, the expected participation of members, and logistical arrangements. Additionally, the group should demonstrate how it would intend to uphold the purpose of these interim measures to ensure compliance with university policies and to avoid any activities that could undermine the forthcoming formal investigation and conduct process. Approval or denial of submitted request(s) for review will be based on the extent to which the proposed activity adheres to these expectations.

Failure to adhere to these noted interim measures could result in SGAF and/or Code of Conduct charges and potential sanction(s) which may include the organization's loss of recognition at the university.
