





Chaplain: In charge of the invocation.

Senate Secretary: Records the minutes of every meeting and prepares the documents for every meeting including the agenda.

Bylaws of the Student Senate

Attendance Policy

Senators are responsible to attend every regularly scheduled Senate meeting. Senators are allowed one unexcused absence.

Absences are considered to be excused if the Senator's absence pertains to: Death in the family (accompanied by an obituary)

University Official Business

Jury Duty

Athletic Team Requirement

Emergency (Verified by the President of the Senate)

A warning letter will be sent by the Agenda and Replacements Committee to the Senator in violation of the Attendance Policy after one unexcused absence. If any unexcused absence occurs after the warning letter has been submitted and received, the Senator will be removed from office. * All excuses have to be properly documented, signed, and given to the Senate Secretary to serve as documentation for an excused absence.

Tardy Policy

Regularly scheduled Senate meetings begin at 11 a.m. Senators are allowed a 10 minute grace period to arrive at the meetings before receiving a tardy penalty. Two tardies will equal one unexcused absence.

Dress Code

Senators are required to dress in business casual attire during a regular Senate session unless otherwise excused by the Senate Chair. Business casual attire includes:

No jeans, T-shirts, or Tennis shoes

Slacks, Dress shirts

Skirts, Blouses

*Senators who may be arriving from places of employment are permitted to wear respective attire.

Senators who fail to adhere to the Dress Code Policy will be docked five dollars from his/her Senate stipend.

Bylaws of the Student Senate

Rules & Regulations

Regulation 1: The Legislative Branch will practice Robert's Rules of Order (Newly Revised Edition) during Senate sessions.

Sanction: Senators deemed "out of order" during a legislative session will be given two warnings by the Sergeant-At-Arms. If a Senator receives a warning after his/her second warning, then he/she will be removed from the chamber at the discretion of the Sergeant-At-Arms.

Regulation 2: Every member of the Senate body will serve on at least one committee and attend all of his or her committee meetings in the Student Senate unless properly excused.

Sanction: If a Senator does not serve on a committee or attend his or her committee meetings sanctions will be enforced by the Senate Replacement Committee at their discretion.

Regulation 3: Senate polos or t-shirts and black or khaki slacks must be worn at all official SGA events and the SGA President's State of the Association Address.

Sanction: Your attire will be noted and considered a dress code violation but no penalty will be assessed. A verbal warning will be given by the President of the Student Senate.

Regulation 4: NO EATING IS ALLOWED IN CHAMBER UNLESS A SENATE MEETING IS BEING CATERED!!!

Description of Committees

Budget and Finance Committee: Members of this committee will be responsible for keeping track of the amount of money taken from the line items of the SGA Budget every meeting. The Student Organization Funding committee will be a sub-committee under the Budget and Finance Committee.

Constitutional Revisions Committee: Every member of this committee will be responsible for revising articles and sections of the constitution as instructed by the rules of the student Senate. This committee will also create proposals for bylaws to the Constitution.

Senate Evaluations Committee: Members of this committee will be responsible for conducting the evaluation process and keeping track of all documentation surrounding violations of rules as it pertains to each Senator. Members of this committee will also be responsible for finding students to replace Senators who resign or are expelled from the student Senate.

Student Government Association Senate Committees

Description of Committees cont...

Student Interests Committee: Members of this committee will be responsible for finding out what the students at Alabama State request, require, and advocate to achieve better campus life. Members of this committee will also be responsible for planning events for the students to interact with their Senate and become more familiar with the systems and branches of SGA. This committee will work closely with the Secretary of Special Projects and Major Events in the SGA President's cabinet.

Appointment and Conformation Committee: Members of this committee will be responsible for interviewing potential members of SGA when they are appointed by the SGA President. This committee will give their opinion to the Student Senate, and then the Senate will vote based off this committee's opinion.

- P17, 3-17-h, Is attorney general going to get scholarship and a student employment contract, and on page 30, should Chief Justice receive tuition stipend? (5-6-i)

Opinion:

I do not think that the attendance policy needs to be in our constitution. Even though it may be the guiding principle for students going to class, it doesn't have anything to do with how they are governed. I think the attendance policy may just need to be in the ASU Pilot.

Even though the Attorney General and Chief Justice may have big responsibilities I do not think they should receive a scholarship and a student employment contract. I think they should only receive a student employment contracts.

.

- Scholarships for the attorney general and chief justice might be good incentives, because it shows that we value all branches of government.
- Consideration: If these people are in these positions (until graduation, as this new constitution states) for their whole time at ASU, they will essentially get their degree for free.
- Where is this money going to come from?
- P19, 4-2-b, What about a senator for Graduate School or will we count one of the senators-at-large as their representative? Maybe you can talk to Dr. Dowdy about whether we should have an official Graduate School senator or not.
- What about inserting "All persons enrolled at Alabama State University are members of SGA," as in Article
 2, Section 1 of the original constitution?
- What about inserting the preamble of the original constitution?
- P27, Elaborate: Limitations of Power (4-17). I still don't fully understand what this means.
- I understand no class officers, but what about class queens?
 - See Article 9, Section 2 of original constitution.

- We could have class queens so that each class could still have at least some form of formal representation, especially considering the new way we plan to elect Miss ASU's Court.
- They can also plan events for their respective classes.

- (8-4-a) Why these particular people on the board?
- (8-6) What is the limit on the number of executive editors? Otherwise, we may be giving a lot of scholarships and student employment to people.
- P38 Programming Branch? (11-5) I still don't know what this is.
- P37 Recall petition, 2nd to last line (10-1)
 - What does the following mean: "The recall petition shall be filed with the officer with whom the
 petition for nomination to such office should be filed, and the same officer shall order the special
 election when it is required."
