In signing your name below, you, the undersigned, in consideration of the privilege of participating in the specific program described in the San Antonio College Trip Participation Information Sheet attached, verify that you have read, understand and agree to the following terms and conditions of your participation:

Responsibilities of Participant

- 1. I will attend the organizational meeting, as scheduled, prior to the trip.
- 2. I will meet scheduled departure times and use services, facilities or equipment provided for trip participants and/ or specifically assigned to me.
- 3. I will lodge in the specific room assigned to me.
- 4. I will pay my non-refundable trip deposit at the time I sign this agreement.
- 5. I will pay the balance of trip costs, as indicated on the San Antonio College Trip Participation Information Sheet attached, on the date specified therein.
- 6. I will pay all debts and settle all accounts for food service, telephone or other purchases not included in the trip price before departing from any destination area.
- 7. I agree to abide by Federal, State and local laws, the policies of the Alamo Community College District, the San Antonio College Student Code of Conduct or other Alamo Community College District College Student Code of Conduct as it may apply to me, and any other additional rules or directives advanced by San Antonio College officials with regard to this specific trip.

Trip Costs, Services, Transportation, Itinerary, Accommodations and Refunds

- 1. lunderstand that the trip price indicated on the attached San Antonio College Trip Participation Information Sheet is based upon expected levels of group participation and on the rates and tariffs in effect and provided by the contracting services at the time the trip was planned. I further understand that trip prices, itineraries, services, transportation and/or accommodations may vary in the event that all places are not sold, or if departure schedules are not met, or should other events or circumstances arise beyond the control of San Antonio College.
- 2. I understand and agree that all expenses beyond those covered by the trip package are my direct responsibility.
- 3. I understand and agree that San Antonio College has served as an arranger and organizer for this trip, and that the services provided are those of contracted services not affiliated with San Antonio College. I understand that San Antonio College is not responsible, and I agree not to hold San Antonio College responsible, for any inconvenience, loss or damage to property or baggage, changes in services, accommodations, facilities, itineraries, transportation and/or accommodations, or any other services provided by contracted agencies and their employees or agents.
- 4. I understand and agree that San Antonio College, as a community college in the Alamo Community College District, is a non-profit institution, and does not offer trip packages for profit; however, i understand and agree that those agencies and businesses contracted to provide services for these trip packages are, in most instances, profit-making concerns, and that with regard to refunds of trip costs from these services. San Antonio College only agrees to be responsible for the return of any refunds received on behalf of the participant from such contracted services, and for none other. I understand that, generally, refunds are not available from contracted services for partial or unused lodging, transportation or other services, and that San Antonio College is not responsible, nor shall I attempt to hold San Antonio College responsible, for losses or additional expenses due to delays or changes in transportation included in this trip package. Refunds of trip deposits apply to offset administrative and overhead costs and are never refundable. Moreover, in the event of inclement weather, strikes, work stoppages, other acts of God, vehicle malfunction or breakdown or other causes or events resulting in additional trip costs, I understand that San Antonio College accepts no responsibility or liability, and agree that San Antonio College shall be held harmless.
- 5. I understand that San Antonio College assumes no responsibility for my failure to meet scheduled departure times or to use the services, facilities or equipment as provided for in the trip package. I further understand that in the event of partial or unused lodging, transportation or other services provided by the trip, or in the event that

I cancel this trip for any reason, including a variance in the price or scheduling of transportation, accommodations or other services provided, there will be no refund of deposits or other payments (unless such other payments are returned to San Antonio College or the participant by the contracted services). I further understand that trips involving bus transportation require a minimum number of participants, and that should fewer than that number register, the trip may be cancelled, and any payments I have made toward the trip package shall be refunded

Insurance

San Antonio College has the right to terminate my participation in this trip, and refunds may or may not be available, as set out in Paragraph II above. I further realize that if I am a student of San Antonio College or other college of the Alamo Community College District, any violation of these rules or regulations may be just cause for disciplinary action, up to and including suspension or expulsion from a college in the Alamo Community College District.
