IF CD ROM'S, DVD'S, ETC. ARE DAMAGED OR LOST, YOU WILL BE SUBJECT TO INDIVIDUAL CURRENT LIST PRICE CHARGES, FOR THE ASSOCIATED TEXTBOOK, AND ANY APPLICABLE LATE FINES.
