Regulations and rules are on the senate website: <a href="http://lydia.bradley.edu/campusorg/senate/">http://lydia.bradley.edu/campusorg/senate/</a> Candidates must be available to attend all regularly scheduled Student Senate meetings on Mondays from 5:00-6:30pm. Candidates must have at least a cumulative 2.25 GPA. Candidates must submit a petition signed by 150 members of the student body and must appear in person or send a written proxy to the mandatory candidates' meeting that is scheduled for Monday, March 2 in Meeting Room 3 in Student Center. Eligibility shall be determined by the Election Sub-committee based on current status at the University and the ability to serve the term in its entirety. All candidates have the option of running independently or as a whole or partial ticket. The positions shall be voted for independent of each other. Elections will be held April 6 & 7, 2015 via Google Form. In order to be elected, a candidate must receive 50% plus 1 votes f there are more than two candidates in the race. If no candidate receives the proper amount to be declared the winner, a runoff will be held April 13 & 14, 2015 via Google Form. Candidates will cast lots at the mandatory candidates meeting to determine placement on the ballot. The candidate name will be listed as it appears on this petition. Candidates must submit their bio/platform and picture to the Elections Subcommittee by March 14, 2015. Tickets may submit a group photo and statement. Campaigning will begin March 12, 2015. The senate Bylaws are currently being amended and changed, so Student Body Officer rules may change.
