FREQUENTLY ASKED QUESTIONS:

1. What is the Student Bar Association (SBA's) roll in the student organization budget allocation process?

The SBA's roll is to submit a budget for the entire SBA. The SBA Board of Representatives (BOR) recommends budget allocation numbers for all student organizations, including SBA, based on the Budget Hearing held once a trimester. The BOR oversees the student organization budget process and recommends budget allocation numbers for all student organizations, including SBA. The BOR takes certain factors into consideration when allocating student organization budgets.

2. What other factors go into how much the BOR allocates to each organization?

Factors include:

- The overall budget available from Student Activity Fees;
- The number of organizations that request funding;
- How much each organization used from past budget allotments;
- Any existing 75% rule violations
- Number of active members in the organization;
- Whether the organization collects dues from its active members;
- If dues are collected, the amount available in the organization's dues account;
- Number of multi-org events;
- Whether organizations asked for funds for things SBA does not allocate money for (e.g., marketing materials above \$2 each with a \$50 total limit, philanthropy events, any events that are not open to the entire CWSL student body, etc.);
- How much money the organization is going to contribute to its events.

3. Once the BOR recommends the budget, what happens next?

The budget is reviewed by Student and Diversity Services and the Business Office to ensure there are no mistakes, and that there is no dishonesty, fraud, or improper use of student funds. Then the budget is sent back to the BOR for distribution.

4. Why does the BOR decide the student organizations' budget?

The BOR members are student representatives from each class elected by his or her peers to represent the interests of his or her classmates on SBA. Each BOR member brings a unique perspective to the budget allocation process, and the voted representatives make decisions with the entire student body in mind. If you would like to take a more active role in the budget process, please participate in the upcoming elections.

5. Why is the BOR allocation process confidential?

California Western is a small law school where the majority of students are familiar with one another. In order to allow the BOR to allocate budgets in the fairest

way possible, the BOR members need to openly discuss his or her thoughts and genuine concerns; a level of confidentially is necessary to achieve this goal. Accountability and transparency is important in a student government; however, it is also important to preserve the integrity and candidness of the SBA BOR.
