2012 ASUC Elections Candidate Filing Form Directions

- 1. For the first blank, please enter your name as it appears on your student ID card.
- 2. If you are affiliated with an ASUC political party, please enter it here. If you would like to create a new party, you may do so by completing a Party Registration Form. This form is separate from the Party Filing Form and is available on the elections website www.election.asuc.org. It needs to be submitted to the Attorney General's mailbox located on the 2nd floor of Eshleman by Friday, March 16th at 5PM. All parties (both new and old) must also turn in a separate Party Filing Form in order to file candidates to run under the party name for the 2012 elections, plus a \$20 fee. These need to be submitted to the Elections Council at the Candidate's Meeting on Tuesday, March 20.
- 3. As outlined in the ASUC Constitution Election By-Laws (Title IV), a candidate must use his/her name as registered with UCB, or a shortened version of their registered name, on the ballot. You may also insert an additional name (i.e., nickname) up to 17 characters (excluding spaces) in length to be printed in quotations along with your registered ballot.

Please write on the form EXACTLY how you would like your name (and optional nickname) to be printed on the ballot. Write legibly.

Please note: As noted in the ASUC Constitution Election By-Laws, Title IV, Section 7.2, point 5, "No candidate may include as part of his/her name, the name of, or reference to, student, faculty, or staff of UC Berkeley without presenting the expressed permission of that person in writing to the Election Council by the Point of No Return during the Candidates' Meeting."

- 8. You may run for more than one office. Please circle neatly and turn in a \$5 filing fee per office sought when turning in your filing form to the 4th floor of Eshleman Hall.
